**Matter requiring a vote of the members of the WWFN - NEW proposed amendments to the Deliberative Assembly Procedures Code**

On or around September 17, the Returning Officer sent an initial mailing to WWFN members entitled to vote, in accordance with the WWFN Voting Code, to submit proposed amendments to the WWFN Deliberative Assembly Procedures Code.

Due to the Canada Post strike, there is a possibility that some WWFN members may not have received the first mailing from the Returning Officer prior to the strike.

The WWFN decided on or around October 4, following discussions with the Returning Officer, to postpone the postal voting period. The vote count originally scheduled for November 15, 2025 will therefore take place on **December 20, 2025, at the same time at the Hôtel Universel in Rivière-du-Loup.**

Consequently, the information session originally scheduled for October 7 has been postponed to **November 19, 2025.**

If you have received a version dated September 17, 2025, please note that it is not up to date. **The vote must be taken on the version of the proposed amendments included in this mailing.**

The votes will be counted on December 20, 2025 at the Hôtel Universel in Rivière-du-Loup after voting has closed at 12:00 p.m. (noon), and the results will be announced immediately afterwards.
